Technical Assistance and Training This program provides support and resources to develop and expand capacity of school health staff and to strengthen school health services and school-based health center sustainability. OSBHA provides training, facilitates key discussions among stakeholders, and provides project management and oversight for school-based staff and student wellness initiatives. OSBHA also works with health and education partners to develop innovative system initiatives and programming to enhance community wellness as well as student academic and attendance outcomes. We serve as a convener and leader in system innovation. OSBHA also provides pass-through funding and support to sites for program development and implementation. Accomplishments this year include: Community Engagement and Convening OSBHA developed and facilitated a community collaborative in partnership with the Central School District with a goal to address barriers to absenteeism. The collaborative brought together regional and community health and youth supporting partners to create a cross-sector and multi-tiered system of support for students. This resulted in the leveraging of resources and streamlined referral system. OSBHA supported school health needs assessments and planning processes with the Greater Albany School District, Newberg School District, and Clackamas Educational School District. This included community engagement, facilitation of planning and advisory committees, and planning for the development of both school nurse and school-based health center models. Positive Youth Development ACTION grants totalling \$44,000 were awarded to four SBHCs in Clackamas, Multnomah, Umatilla and Crook counties to facilitate healthy youth relationship programming. Developed and implemented a statewide Youth Action Council Summit. Created a Youth Action Council Coaching Model for SBHCs that includes assisting and developing sustainable youth councils through support with youth-adult partnership, facilitation, recruitment, project management, community partnership development, and cultural responsiveness. Provided coaching and technical assistance to SBHCs in Ione and Hood River. OSBHA supported and partnered with 16 Student Health Advocates to strengthen the youth voice in healthcare access and promotion of healthy relationships. The youth participated in over thirteen events throughout the state. A peer-to-peer HPV prevention curriculum was developed and presented to high school students at Centennial High School. These students also began to develop a training for healthcare providers on youth-oriented HPV prevention.

2. Advocacy This program aims to influence public policy and resource decisions within political, economic and social systems. Approaching policy makers, including legislators, we address issues relative to the expansion of school health care and quality of that care, as well as policy agenda items. All advocacy is non-partisan and unrelated to any campaigns for office. Advocacy includes social media campaigns, public speaking and community organizing around a central issue. Social media, electronic newsletters, action alerts and our website are all important in communication with our members, champions, stakeholders and grassroots advisors who message to a variety of audiences. A central component of our advocacy is to build the ability of youth to participate in decision-making processes that impact them.
