FAMILY RESOURCE CENTER - THE FAMILY RESOURCE CENTER PROGRAM PROVIDES A VARIETY OF ACADEMIC ENRICHMENT, ARTS & CRAFTS, RECREATION, YOUTH LEADERSHIP AND YOUTH DEVELOPMENT ACTIVITIES FOR CHILDREN AND YOUTH IN THE COMMUNITY. IT ALSO PROVIDES ADMINISTRATION AND COORDINATION OF SERVICES LOCATED IN HOUSING PROJECTS OF THE ST. CLAIR COUNTY HOUSING AUTHORITY'S BUILDINGS FOR YEAR-ROUND PROGRAMMING.
