DCFS or private agency caseworkers can access those funds to purchase services or goods that will aid in the reunification or permanency of the family they are serving. OTHER PROGRAM SERVICES 17: IN-HOME INTENSIVE - This is a county-based grant that provides in-home therapy to families in Marion County. This program provides counseling/stabilization services in the home of youth who qualify for Redeploy funds through the state. Spero has an agreement with Clinton County Probation to work with the youth and family using evidence-based practices. The purpose of the program is to work with families to address parenting and trauma issues that will hopefully keep the youth out of the juvenile justice system.</p>
