Accordingly, the Nursery has not recorded any reserves, or related accruals for interest and penalties for uncertain income tax positions at June 30, 2019. The Nursery is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress. The Nursery believes it is no longer subject to income tax examinations for years prior to 2016. The Nursery's policy is to classify income tax related interest and penalties in interest expense and other expenses, respectively.</p>
