JTG specialists (teachers) are full-time employees of either JTG or their respective school districts During the 2015-216 school year, the 18 JTG programs achieved a 99% graduation rate The 2015 graduates who were tracked for 12-months by the specialists achieved a 68% positive outcome rate meaning they have a job, are in post-secondary education, or both The most significant achievement is the return on investment with this at-risk population Studies show that a high school dropout will cost society (you and me) nearly 300-thousand dollars by living off state/federal programs, not paying taxes and possibly incarceration at 30-thousand dollars per inmate per year in the state of Tennessee
