Y programs, such as our 4th Grade Safety Around Water, Financial Assistance Program, Safe Places Afterschool Program and the numerous special needs camps we offer, are just a few examples of how we deliver resources and support that empowers our neighbors to effect change, bridge gaps, and overcome obstacles. The Y Safety Around Water (YSAW) program is a collaboration with the Flint Community Schools and the Ruth Mott Foundation. During the 2018-2019 school year approximately 313 4th grade students participated in the 7 week Y Safety Around Water. YSAW provides these 4th grade students with simple and straightforward ways to ensure their safety in and around the water. The goal of the YMCA of Greater Flint/Flint Community Schools partnership is to lessen the number of deaths due to drowning, currently the second leading cause of accidental death for youth in Michigan and the nation. This rate of drowning increases if the youth is male, African-American, and impoverished. In a community which experiences a poverty rate of approximately 49% with a large African-American urban population this is an important issue. Overwhelmingly, students from Flint Community Schools who participated in this program in the 2018-2019 school year improved their swimming skills and became safer around water as a result. The YMCA is dedicated to reaching children in ways that will keep them safe and improve their quality of life. Swimming is more than a recreational skill, it's a skill that can save lives, and it is vitally important that we provide this opportunity to kids from all socio-economic groups at an early age. The YMCA of Greater Flint raises money annually to support its financial assistance program. Over, 8,000 people in our community were able to receive scholarships to participate at the Y because of our Partner with Youth Campaign. At the YMCA, we believe that no one should be turned away because of their inability to pay. We provide financial assistance for memberships, youth programs, and camping experiences throughout the year. Through our partnerships at Camp Copneconic, we are able to provide camping experiences for children with diabetes, cancer, Crohns and Colitis, children from foster programs and a variety of other unique situations. Through our extensive partnerships, we are continuing to positively impact our community in the areas of youth development, healthy living and social responsibility. Working with other youth organizations like Boys and Girls Club and Whaley's Children Center we are able to offer life-changing experiences to youth.

Safe Places Another way the YMCA of Greater Flint is developing youth in our community is through the Y Safe Places initiative. Through this program the Y provides safe, quality services to youth, grades K-12, residing in the Greater Flint Area. Over 1,800 youth have been served through The Y Safe Places Program, now in its third year. The four Safe Places sites, provide year-round programming to maximize every opportunity to reach targeted youth. In addition to being easily accessible for neighborhood youth and families, Safe Places has established the following goals: (1) To provide quality care for all children; in a safe, structured environment; (2) To improve quality of life, health, and self-esteem; (3) To support and strengthen the family unit; (4) To help children develop to their fullest potential; and (5) To teach the importance of physical activity throughout life. Safe Places also expanded its nutritional services through a partnership with the Genesee County Community Area Resource Department (GCCARD) that allowed us to hold programming and feed students lunch at 7 local area parks for free to the participants.

Swim Team The YMCA Flint Falcons is a competitive swim team comprised of swimmers from the greater Flint area. This USA and YMCA sanctioned swim team's mission is to develop the character traits, technical skills and intense desire necessary for maximum realization of each individual's highest goals, including the Olympic dream. This dynamic team brings all youth to realize their unique athletic talent in the pool regardless of social economic status, race, or religion. This program is particularly important to African-American, inner city males who have a statically higher chance of drowning. Youth thrive from having consistent, low-impact exercise as well as the emotional and mental benefits of team sports. Besides these physical, mental, and emotional benefits, high school youth can use team participation to receive a college scholarship as well as job skills working as a lifeguard or aquatic coordinator. Through the guise of physical competition, this swim team sets up youth for success by developing them mind, body, and spirit.
