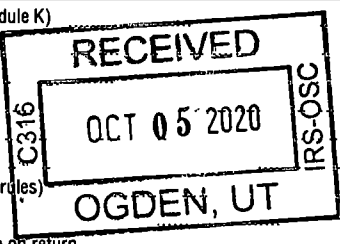

LINE 34 HAS BEEN AMENDED TO REMOVE THE \$15,945 OF 512(A)(7) QUALIFIED TRANSPORTATION FRINGE ACTIVITY ORIGINALLY REPORTED. THIS RESULTED IN UNRELATED BUSINESS TAXABLE INCOME BEING REDUCED TO ZERO ON LINE 38 AND TOTAL TAX BEING REDUCED TO ZERO ON LINE 44.
