4d Youth Development/ Social Responsibility - Swim, Sports and Play Through active play children learn the lifetime value of staying physically fit Year-round youth sports, martial ways, gymnastics, swimming, and outreach programs help young people cultivate the skills, values and relationships that lead to positive behaviors and better health The Ann Arbor YMCA has partnered with a number of other community organizations to identify and respond to community needs Swimming is an essential life skill, particularly in a state where one is never more than six miles from a lake or stream The Y offers a week of free SAFETY AROUND WATER classes both at the downtown Y facility and at apartment complexes in Washtenaw County, as well as swim classes for both youth and adults, a swim team and a synchronized swimming program Our Y was awarded a generous grant of \$20,000 annually for four years from The Women's Sports Foundation (WSF) and Ralph C Wilson Jr Foundation through the new Regional Sports 4 Life program to fund the Young Women Making Waves Program, a swim program for under-served girls in eastern Washtenaw County In 2018, 659 children were provided with a week of free water safety lessons and 2,068 children participated in swim programs For a second year, The Ann Arbor YMCA, in collaboration with the Washtenaw County Sheriff's Office, Ypsilanti Community Schools and Washtenaw County Parks and Recreation Department, offered the East Washtenaw Basketball League program, which provided ten weeks of basketball league for Ypsilanti students in grades 6-12 at the Ypsilanti Community Middle School The program's mission is to provide enriching programs that connect youth in Eastern Washtenaw County with opportunities to engage with caring adults outside of school and home life In 2018, 40 Ypsilanti students participated in this sponsored East Washtenaw Basketball League program

4a Health Living - The Ann Arbor YMCA is a leading voice on improving the health and well being of the Washtenaw County community. We bring families together, foster connections and encourage good health through shared fitness, recreational and social activities. Health and well-being are all about balance. That's why we help individuals and families build and maintain healthy habits for spirit, mind and body in their everyday lives. By helping people of all ages and all backgrounds improve their health and well-being, we build a stronger community. As a result, 27,333 individuals in the Ann Arbor, Ypsilanti and surrounding Washtenaw county community are receiving the support and resources to achieve health in spirit, mind and body. This is particularly important as our nation struggles with an obesity crisis, families struggle with work/life balance issues and individuals search for personal fulfillment. The Y has a number of programs designed to fight chronic disease and is committed to empowering our community to lead fuller lives. Our healthy living programs include Pedaling for Parkinson's, a bicycle program to help reduce disease symptoms, Livestrong, a free fitness and support program for cancer survivors, Diabetes Prevention Program, Arthritis Exercise, and Moving for a Better Balance. In 2018 over 400 people participated in these programs. Y programs are accessible, affordable and open to all faiths, backgrounds, abilities and income levels. In 2018 the Ann Arbor Y provided \$717,130 in financial assistance to individuals who would have faced economic barriers to participation in the areas of Healthy Living, Youth Development and Social Responsibility.

4b Youth Development - Summer Camps The YMCA is committed to nurturing the potential of every child and teen. We believe that all children deserve the opportunity to discover who they are and what they can achieve. In 2018 The Y offered camp programs for youth ages 5-16 at three Ypsilanti sites, downtown Ann Arbor, Silver Lake in Pinckney (Camp Birkett) as well as a residential camp in northern Michigan on Burt Lake (Camp Al-Gon Quian). Summer programs are rooted in the YMCA core values of caring, honesty, respect and responsibility while being intentional about fostering friendships, a sense of accomplishment, and belonging for all. Our day camp programs in Washtenaw County and on Burt Lake at Camp Al-Gon-Quian provide a safe community where young people explore, build self-esteem and interpersonal skills and make lasting friendships and memories. A new collaboration, started in 2018, with the national organization "Light Up" enabled the Y and volunteers to teach 20 differently-able children to ride a bike in just five days. This skill will allow these children a measure of independence, confidence and the ability to interact with their family and peers in a very positive way. In 2018, the Ann Arbor YMCA served 1,769 children enrolled in day camps in Washtenaw County and St. Livingston County and 1,151 campers attended residential Camp Al-Gon-Quian on Burt Lake. 586 campers received campership in 2018 to attend Y summer programs.

4c Youth Development/Social Responsibility programming includes Child Care, Teen Education, Leadership and Youth Volunteer programs. Youth development programs give children and teens a safe place to belong, build confidence and learn positive behaviors. Child Development. The YMCA's NAEYC-accredited Early Child Care and After School programs provide a nurturing environment where children can learn, grow and develop social skills. These programs guide children through an age-appropriate curriculum that develops self-help skills and instills the Y values of honesty, caring, respect and responsibility among children and their families. An additional element to Y child care programs is the healthy eating physical activity curriculum implemented to help reduce childhood obesity. The YMCA's school age Child Care Program and Teen after School Program provide a safe, comfortable environment for children that includes healthy snacks and help with homework, plus physical indoor and outdoor activities with our caring staff. In 2018, the Y expanded its commitment to quality child care in Ypsilanti by launching the Ypsilanti YMCA Child Development Center in collaboration with Eastern Michigan University (EMU), Ypsilanti Housing Commission (YHC) and Ypsilanti Community Schools (YCS). The Center serves families from these collaborators and families within the community with three bright classrooms and extended hours just one mile from the EMU campus. In 2018 the new center served 33 children. Once it has been in operation for over a year (a requirement) it is expected to also be NAEYC - accredited. The Y makes it possible for families of all backgrounds and income levels to participate in our programs on a sliding fee scale. At the Y, we help teens set and achieve their goals. Through Teen Education and Leadership programs, including the Teen After School Program, Youth in Government and Leaders Club, teens ages 11-17 have the opportunity to develop self-confidence and take an active role in strengthening their community. Youth Volunteer Corps (YVC) is a youth driven volunteer program for young people ages 11-17. YVC engages youth in service-learning projects that are challenging, rewarding and educational to serve the need of the community and promote a lifetime ethic of service. YVC is offered as an accredited Community Resource Class (Creating and Maintaining Socially Just Communities with the YVC Corps) in the Ann Arbor Public Schools for grades 9-12. In 2018, 363 youth volunteers collaborated on 214 projects with 30 non-profit agencies to provide over 10,025 hours of service to the Washtenaw County community. Michigan Youth in Government (YIG) is a comprehensive program that teaches state governmental process in a fun, interactive and exciting way. Participants learn about bill-writing, parliamentary procedure, current issues facing the state of Michigan, and much more. In 2018, 92 middle and high school students from Ann Arbor and Ypsilanti participated in the YIG program. Representatives from the Ys middle school delegation were elected as Lieutenant Governor and Speaker of the House by their peers at the state-wide conference. Leaders Club - Leaders Club provides teens opportunities for personal growth and leadership development. Club meetings encourage character development through activities such as team-building, group work, volunteering for YMCA events, interning within a YMCA department, leadership training and much more. In 2018, 23 youth participated in Leaders Club Programs.
