Form 990 Part X - In preparation of tax returns, tax positions are taken based on interpretation of federal, state and local income tax laws. The Agency has evaluated the provisions of ASC Topic 740, Accounting for Uncertainty in Income Taxes. The Agency concluded that there are no significant uncertain tax positions requiring recognition in the Agency's financial statements. The Agency is not aware of any adjustments to the tax returns as filed, or is it aware of any claims for amounts owed from the taxing jurisdictions.

Community Action Agency's Form 990 is prepared by the Agency's Chief Financial Officer, who is a Certified Public Accountant, and reviewed by it's Chief Executive Officer. It is received and approved by the Agency's Finance and Audit Committee, and ultimately the full Board of Directors.
