The Agency is not aware of any adjustments to the tax returns as filed, or is it aware of any claims for amounts owed from the taxing jurisdictions.

The Agency's Executive Committee performs an annual evaluation of the CEO, which includes performance evaluation and compensation comparability. The Executive Committee then makes a recommendation to the full Board of Directors.
