OUR KINDER-CARES PROPOSAL WAS SELECTED FOR FUNDING, BEGINNING IN FY 22, THRU SEPTEMBER 2026. THE PROJECT VISION IS TO TRANSFORM THE RELATIONSHIPS AND INTERACTIONS BETWEEN CHILD WELFARE STAFF, THE COMMUNITY, FOSTER PARENTS, KINSHIP CAREGIVERS AND PARENTS WHICH WILL CREATE A FOUNDATION FOR THE APPROACHES AND INTERVENTIONS THAT WILL IMPROVE STABILITY, PERMANENCY AND FAMILY-FOCUSED WELL-BEING. ACADEMY FOR FAMILY SUPPORT AND PRESERVATION THE QUALITY IMPROVEMENT CENTER FOR ADOPTION AND GUARDIANSHIP (QIC-AG) CONTINUES TO CREATE AND DISSEMINATE NEW PRODUCTS, WORK WITH SOME OF OUR ORIGINAL PILOT SITES, AND ESTABLISH WORKING RELATIONSHIPS WITH NEW SITES. WE CONTINUED TO WORK WITH FOUR OF THE ORIGINAL PILOT SITES: ILLINOIS, TENNESSEE, VERMONT AND CATAWBA COUNTY NORTH CAROLINA. LAST FISCAL YEAR, EIGHT NEW SITES BEGAN WORKING WITH THE QIC-AG (MARYLAND, NORTH DAKOTA, MISSOURI, CONNECTICUT, MICHIGAN, OKLAHOMA, OREGON AND GEORGIA) TO COMPLETE CAPACITY BUILDING ACTIVITIES. THROUGH OUR WORK, THE QIC-AG HAS AMASSED AN ARRAY OF PRACTICAL TOOLS, MATERIALS, AND CONTENT USEFUL FOR MEMBERS OF THE CHILD WELFARE COMMUNITY AS WELL AS ALLIED PROFESSIONALS. TO MAKE IT EASY TO DISCOVER WHAT MAY BE MOST RELEVANT TO OUR TARGET POPULATIONS, WE CREATED A "VIRTUAL TOUR", WHICH CAN BE WATCHED ON YOUTUBE. THE VIDEO WAS SENT TO OUR TARGET POPULATIONS WITH A PARTICULAR FOCUS ON PRIVATE PROVIDERS. THE NATIONAL TRAINING AND DEVELOPMENT CURRICULUM FOR FOSTER AND ADOPTIVE FAMILIES (NTDC) BASED ON THE FEEDBACK WE OBTAINED FROM OUR PILOT SITES AND FAMILIES WHO PARTICIPATED IN NTDC, WE ARE IN THE PROCESS OF FINALIZING THE CURRICULUM WITH THE GOAL OF HAVING ALL EDITS COMPLETED AND AVAILABLE FOR PUBLIC DISSEMINATION IN JUNE 2022. WE FINISHED REVISING THE RIGHT-TIME THEMES AND COMPLETED MAKING THE THEMES 508 COMPLIANT. WE HAVE BEGUN REVISIONS TO THE CLASSROOM-BASED THEMES WHICH WILL CONTINUE THROUGH THE YEAR. WE HAVE ONBOARDED ONE NEW ADOPTION SERVICE PROVIDER WHO WILL IMPLEMENT NTDC BUT NOT AS PART OF THE PILOT. VIRGIN ISLANDS AND MAINE CONTINUE TO OFFER NTDC BUT NOT AS PILOT SITES. WE CONTINUE TO WORK WITH OREGON ON GETTING NTDC IMPLEMENTED. AS OF JUNE, 2021, A TOTAL OF 2,499 PARENTS WHO ARE FOSTERING, ADOPTING OR CARING FOR RELATIVES (KINSHIP CAREGIVERS) PARTICIPATED IN THE NTDC TRAININGS. OF THESE, 1,102 VOLUNTEERED TO BE A PART OF THE EVALUATION. PARTICIPANT COMPETENCY GAINS ARE HIGH. TO DATE, ALL OF THE DATA IS SHOWING POSITIVE TRENDS. PARTICIPANTS ARE OVERWHELMINGLY SATISFIED WITH THE CURRICULUM. WE PARTNERED WITH THE NORTH AMERICAN COUNCIL ON ADOPTABLE CHILDREN (NACAC), THE NEW ENGLAND ASSOCIATION OF CHILD WELFARE COMMISSIONERS AND DIRECTORS (NEACWCD), THE UNIVERSITY OF NEBRASKA AT LINCOLN (UNL), AND THE UNIVERSITY OF WASHINGTON (UW) TO DEVELOP A FEDERAL GRANT PROPOSAL TO ESTABLISH THE NATIONAL QUALITY IMPROVEMENT CENTER ON ENGAGING YOUTH IN FINDING PERMANENCY. OUR PROPOSAL WAS SELECTED FOR FUNDING FOR THE PERIOD BETWEEN FY 22 THROUGH FY 26. THE QIC-EY IS EXPECTED TO BRING SYSTEMIC CHANGE THAT WILL BE REFLECTED THROUGH INTENTIONAL POLICIES, PRACTICES, AND CULTURE SHIFTS. MINORITY PROFESSIONAL LEADERSHIP DEVELOPMENT PROGRAM (MPLD) THE THIRD COHORT BEGAN IN OCTOBER 2020 AND ENDED IN SEPTEMBER, 2021. THE MPLD PROGRAM PROVIDED PROFESSIONAL DEVELOPMENT TO 16 MINORITY CHILD WELFARE PRACTITIONERS FROM 15 STATES. CURRENTLY, THREE COHORTS OF FELLOWS HAVE TRANSITIONED TO THE ALUMNI NETWORK, AND WE CONTINUE TO PROVIDE SUPPORT TO THE ALUMNI. OVER 50% OF MPLD ALUMNI AND FELLOWS HAVE BEEN PROMOTED EITHER DURING THE FELLOWSHIP OR AFTER COMPLETION OF THE FELLOWSHIP. THE MPLD TEAM HAS IDENTIFIED AN ALUMNI AMBASSADOR FOR EACH COHORT WHO WILL ASSIST IN KEEPING ALUMNI ENGAGED.

WE FINISHED REVISING THE RIGHT-TIME THEMES AND COMPLETED MAKING THE THEMES 508 COMPLIANT. WE HAVE BEGUN REVISIONS TO THE CLASSROOM-BASED THEMES WHICH WILL CONTINUE THROUGH THE YEAR. WE HAVE ONBOARDED ONE NEW ADOPTION SERVICE PROVIDER WHO WILL IMPLEMENT NTDC BUT NOT AS PART OF THE PILOT. VIRGIN ISLANDS AND MAINE CONTINUE TO OFFER NTDC BUT NOT AS PILOT SITES. WE CONTINUE TO WORK WITH OREGON ON GETTING NTDC IMPLEMENTED. AS OF JUNE, 2021, A TOTAL OF 2,499 PARENTS WHO ARE FOSTERING, ADOPTING OR CARING FOR RELATIVES (KINSHIP CAREGIVERS) PARTICIPATED IN THE NTDC TRAININGS. OF THESE, 1,102 VOLUNTEERED TO BE A PART OF THE EVALUATION. PARTICIPANT COMPETENCY GAINS ARE HIGH. TO DATE, ALL OF THE DATA IS SHOWING POSITIVE TRENDS. PARTICIPANTS ARE OVERWHELMINGLY SATISFIED WITH THE CURRICULUM. WE PARTNERED WITH THE NORTH AMERICAN COUNCIL ON ADOPTABLE CHILDREN (NACAC), THE NEW ENGLAND ASSOCIATION OF CHILD WELFARE COMMISSIONERS AND DIRECTORS (NEACWCD), THE UNIVERSITY OF NEBRASKA AT LINCOLN (UNL), AND THE UNIVERSITY OF WASHINGTON (UW) TO DEVELOP A FEDERAL GRANT PROPOSAL TO ESTABLISH THE NATIONAL QUALITY IMPROVEMENT CENTER ON ENGAGING YOUTH IN FINDING PERMANENCY. OUR PROPOSAL WAS SELECTED FOR FUNDING FOR THE PERIOD BETWEEN FY 22 THROUGH FY 26. THE QIC-EY IS EXPECTED TO BRING SYSTEMIC CHANGE THAT WILL BE REFLECTED THROUGH INTENTIONAL POLICIES, PRACTICES, AND CULTURE SHIFTS. MINORITY PROFESSIONAL LEADERSHIP DEVELOPMENT PROGRAM (MPLD) THE THIRD COHORT BEGAN IN OCTOBER 2020 AND ENDED IN SEPTEMBER, 2021. THE MPLD PROGRAM PROVIDED PROFESSIONAL DEVELOPMENT TO 16 MINORITY CHILD WELFARE PRACTITIONERS FROM 15 STATES. CURRENTLY, THREE COHORTS OF FELLOWS HAVE TRANSITIONED TO THE ALUMNI NETWORK, AND WE CONTINUE TO PROVIDE SUPPORT TO THE ALUMNI. OVER 50% OF MPLD ALUMNI AND FELLOWS HAVE BEEN PROMOTED EITHER DURING THE FELLOWSHIP OR AFTER COMPLETION OF THE FELLOWSHIP. THE MPLD TEAM HAS IDENTIFIED AN ALUMNI AMBASSADOR FOR EACH COHORT WHO WILL ASSIST IN KEEPING ALUMNI ENGAGED.</p>
