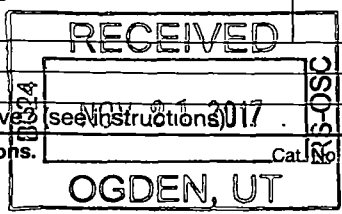

HUNGER: EACH YEAR, THE URBAN MISSION DISTRIBUTES OVER 1 MILLION POUNDS OF FOOD TO FAMILIES IN NEED. OUR CLIENT CHOICE PANTRY WAS OPENED IN 2014, AND CONTINUES TO SUPPORT MORE THAN 5,000 INDIVIDUALS EACH MONTH. THE URBAN MISSION ALSO OPERATES A SOUP KITCHEN WHICH SERVES A HOT MEAL FOUR TIMES A WEEK TOTALING 20,000 MEALS A YEAR. IN 2016, THE URBAN MISSION ALSO SERVED AS A SPONSOR FOR THE SUMMER FOOD SERVICE PROGRAM THROUGH THE USDA AND THE OHIO DEPARTMENT OF EDUCATION. WE SPONSORED THREE SITES IN STEUBENVILLE AND ONE IN A NEIGHBORING COMMUNITY, AND SERVED OVER 2,600 MEALS TO AREA CHILDREN. IN ADDITION, THE URBAN MISSION REMAINS A STRONG PARTNER WITH THE MID-OHIO FOODBANK, SERVING AS A HUB FOR TEN OF ITS LOCAL PANTRIES.

HOMELESS SHELTER: THE URBAN MISSION OPERATES AN EMERGENCY SHELTER FOR HOMELESS FAMILIES CALLED THE HUTTON HOUSE. IN 2015, THE MISSION PURCHASED ANOTHER BUILDING WHICH IS BEING RENOVATED FOR USE AS A SHELTER FOR WOMEN AND CHILDREN, AS WELL AS A RESOURCE CENTER FOR THE COMMUNITY. A HOSPITALITY ROOM IS ALSO AVAILABLE FOR COMMUNITY MEMBERS TO VISIT DURING THE DAY FOR FOOD, SHELTER, HAIRCUTS, AND OTHER PERSONAL SERVICES. THE URBAN MISSION IS A PARTNER AGENCY WITH OHIO DEVELOPMENT SERVICES AND A MEMBER OF THE JEFFERSON COUNTY COALITION ON HOUSING AND HOMELESSNESS.
