The organization is funded through resident room and board charges, Section 8 rental subsidies, Project 515 subsidies, and reimbursements from local mental health facilities for care of individuals residing at the group home. Bridgewood housed 21 emotionally impaired individuals throughout 2015 providing them with 24 hour care and supervision. These residents were also provided daily living skills and participated in group outings. The organization also provided housing to 41 low income residents.
