The clients actively engage with others who have recovery experience, building a new network of support. The bed capacity for the facility is 20 beds. The setting for the facility is serene and private, on 18 acres of land which creates a very comfortable environment for clients to work on these changes in their lives. Bed days provided in 2016 were 5,472 and 339 clients served, which is approximately the same number of bed days as the prior year.

### **Form 990, Part III, Line 4c:**

Detoxification Program This program offers social detoxification services on a 24-hour basis for clients who need medical assistance for symptom relief as they withdraw from their alcohol or drug use. As the client feels better, the staff also work to help build the hope, readiness and resiliency needed to take the next step in the recovery process. This facility has 6 beds. In 2016, 1,306 bed days were provided and 377 clients were served, which represents a 6% decrease in number of clients served from prior year. This program also launched a program expansion in 2015 to offer extended stays to clients needing additional housing and support as they transition to the next level of care. This program was further expanded in 2016 to offer transitional days for clients discharging from residential services. Ongoing costs for this pilot program were \$94,513 in 2016 and 704 bed days were provided.
