Integrated Health Services The Agency has embedded a recovery coach or other behavioral health professionals in the emergency rooms of 7 local hospitals They provide brief intervention and referral services to patients with substance use disorder concerns In 2018, 771 clients were served in the hospital setting In late 2017, the Agency entered into an agreement with a federally qualified health center to provide recovery coaching services on their premises, coordinating care with their behavioral health professionals In 2018, approximately 2,500 recovery coaching encounters were provided at this location
