Total management fees for 2016 was \$12,364. Samaritas has a defined-contribution regular pension plan (Plan), which covers substantially all employees of LSSM who staff the company. The Plan offers employees the opportunity to participate in the ELCA Master Institutional Retirement Plan administered by Portico and their relationship with Fidelity. Samaritas will match 133 percent for each dollar the employee contributes up to 1.5 percent of earnings per pay. The Samaritas contribution will be capped at 2 percent of earnings per pay.</p>
