ENOUGH SAID IS A COLLABORATION AMONG MWF, THE DETROIT CRIME COMMISSION -- BOTH 501(C)(3) NONPROFITS -- AND THE WAYNE COUNTY PROSECUTOR'S OFFICE TO BRING TO PROSECUTION A BACKLOG OF SEXUAL ASSAULT CRIMES, WITH THE ULTIMATE GOAL OF PREVENTING SEXUAL ASSAULT IN THE FUTURE. IT WAS FORMED AFTER MORE THAN 11,000 UNTESTED RAPE KITS WERE FOUND IN A DETROIT POLICE DEPARTMENT STORAGE UNIT IN 2009.
