ENOUGH SAID IS A COLLABORATION AMONG MWF, THE DETROIT CRIME COMMISSION -- BOTH 501(C)(3) NONPROFITS -- AND THE WAYNE COUNTY PROSECUTOR'S OFFICE TO BRING TO PROSECUTION A BACKLOG OF SEXUAL ASSAULT CRIMES, WITH THE ULTIMATE GOAL OF PREVENTING SEXUAL ASSAULT IN THE FUTURE. IT WAS FORMED AFTER MORE THAN 11,000 UNTESTED RAPE KITS WERE FOUND IN A DETROIT POLICE DEPARTMENT STORAGE UNIT IN 2009. THE GOAL OF THE PROJECT IS TO CREATE PRIVATE/PUBLIC PARTNERSHIPS TO FUND THE TESTING OF THE KITS, INVESTIGATION OF THESE CASES AND WORK WITH THE WCPO TO PROSECUTE THE ASSAILANTS, ULTIMATELY STRENGTHENING THIS COMMUNITY. THIS YEAR, NEARLY 500 HIGH PERFORMING BUSINESS AND PROFESSIONAL WOMEN AND ENTREPRENEURS VOLUNTEERED TO PROVIDE EPISODIC COUNSELING AND/OR LONG-TERM MENTORSHIP TO CLIENTS IN THE ENTREPRENEURSHIP AND YOUNG WOMEN LEADERS INITIATIVES.MWF FUND RAISED AND ALLOCATED FUNDS OF MORE THAN \$1M FOR A RESILIENCE FUND PROGRAM WHERE MWF DISTRIBUTED GRANTS UP TO \$5000 AND UP TO \$10,000 IN LOANS TO NEARLY 200 SMALL BUSINESSES ACROSS THE STATE BETWEEN JUNE - SEPTEMBER.
