ADOPTION: WE SERVED 175 CHILDREN AND FACILITATED 74 COMPLETED ADOPTIONS. WE HAVE A CONSULTATIVE SERVICES AGREEMENT UNDER CONTRACT WITH MICHIGAN DHHS (ADOPTION RESOURCE CONSULTANTS) TO EXPEDITE ADOPTIONS IN PROCESS AT OTHER AGENCIES. COMMUNITY PROGRAMS: ORCHARDS COMMUNITY BASED PROGRAMMING ATTEMPTS TO ASSIST THE CHILDREN WE SERVICE AND THE COMMUNITY RELATED TO HOLDING EVENTS THAT MAKE CHILDHOOD MEMORABLE. THESE EVENTS INCLUDE EASTER EGG HUNTS, CAMPING AT SELECTED DAY AND OVERNIGHT CAMPS, AND BIKE DAY WHERE WE ASSEMBLE 400 BIKES AND GIVE THOSE AWAY TO CHILDREN. RECREATIONAL PROGRAMMING IS UNDER THE UMBRELLA OF "SUMMER ADVENTURES" WHICH INCLUDES AS MENTIONED SUMMER CAMP FOR 155 CLIENTS AS WELL AS THE ANNUAL BIKE GIVEAWAY WHERE 400 BIKES, HELMETS AND LOCKS WERE PROVIDED AS WELL AS SAFETY EDUCATION AND RULES OF THE ROAD. THE LARGE COMMUNITY ENGAGED EFFORT TO BUILD THE BIKES GARNERS NEARLY 165 COMMUNITY VOLUNTEERS FOR A DAY OF GIVING BACK. IN LATE SUMMER, ORCHARDS INCLUDES IMPORTANT COMMUNITY INITIATIVES AND EDUCATIONAL SUPPORT TO CHILDREN K-12 WITH BACK TO SCHOOL OPPORTUNITIES WHICH INCLUDE PROVIDING BACK PACKS, CLOTHING AND SCHOOL SUPPLIES TO 900 YOUTH. YOUTH ARE ALSO PARTICIPANTS IN A FREE BACK TO SCHOOL STORE WHERE THEY ARE ABLE TO SHOP FOR FREE FOR ALL NEW ITEMS. IN THE FALL, WE HOST A HALLOWEEN PARTY FOR CHILDREN AND COMMUNITY MEMBERS. AT HOLIDAY TIME, WE GIVE AWAY OVER 400 TURKEYS AND HOLIDAY MEALS AND DURING DECEMBER, WE HAVE A TOY DRIVE AND ENSURE EACH CHILD WE SERVICE HAS GIFTS FOR THE HOLIDAYS. IN ADDITION, WE ALSO INVITE COMMUNITY MEMBERS TO ADOPT OVER 40 FAMILIES AS THEY SHOP TO MAKE THOSE FAMILIES HAVE THE MOST MEMORABLE HOLIDAYS EVER. MANY OF THESE ACTIVITIES BEGINNING IN THE MIDDLE OF MARCH 2020 HAD TO BE SUSPENDED DUE TO THE PANDEMIC AND OUR INABILITY TO HAVE LARGE GATHERINGS. WE DILIGENTLY CONDUCTED ALL THESE ACTIVITIES FOR THE FIRST SIX MONTHS OF THE FISCAL YEAR AGAIN UNTIL THE STATE ENTERED A STATE OF "STAY HOME STAY SAFE" IN MARCH 2020. HEALTH AND WELLNESS INITIATIVES WOULD NORMALLY INCLUDE THE COMMUNITY GARDEN AND FOOD DEMONSTRATION KITCHEN; BASIC NEEDS SUCH AS ORCHARDS CLOTHING CORNER PROVIDE NEEDED CLOTHING TO CHILDREN ENTERING THE FOSTER CARE SYSTEM, AS WELL AS THE GUARDIANSHIP PROGRAM AND FAMILY PRESERVATION SUPPORT. ORCHARDS PARTNERS WITH THE JEWISH VOCATIONAL SERVICES (JVS) TO PROVIDE EMPLOYMENT OPPORTUNITIES FOR MENTALLY CHALLENGED CLIENTS IN THE CLOTHING CORNER. ADDITIONAL BASIC NEEDS ARE PROVIDED VIA FURNITURE ACQUISITION AND DELIVERY TO OVER 100 HOUSEHOLDS ANNUALLY. THIS INCLUDES BEDS, SOFAS, APPLIANCES, DRESSERS, DINING TABLES ETC. ORCHARDS WAS ABLE TO DO ALL OF THE ABOVE ACTIVITIES LISTED IN THIS PARAGRAPH EVEN DURING THE PANDEMIC WITH THE EXCEPTION OF THE COMMUNITY GARDEN AND FOOD DEMONSTRATION, WHICH OCCURS IN THE SPRING AND SUMMER.
