 The Center for Women is a pregnancy resource center which provides counseling, education and practical assistance to women and men in the Jackson area. Services we provide include education and material assistance for both moms and dads through our Learn and Earn and Dads All In programs. During the year we assisted 115 clients with 437 client visits. This service included 29 ultrasounds and 51 pregnancy tests.
