The Organization reimburses Samaritas for all related staffing expenses. An employee of Samaritas also serves as the on-site manager for the Organization. Samaritas provides certain management services to the Organization in accordance with a management services agreement. Under the terms of the agreement, the Organization pays Samaritas a management fee equal to 6.06% of rental income which is limited to \$44 per occupied unit per month. Total management fees for 2016/2017 were \$13,744. Samaritas provides certain accounting services to the Organization in accordance with the annual budget. The accounting fees for 2016/2017 were \$3,960. Samaritas offers employees the opportunity to participate in the ELCA Master Institutional Retirement Plan administered by Portico and their relationship with Fidelity. Employees are eligible to defer a portion of their earnings on a pre-tax basis into the Plan to save for retirement. Samaritas provides a matching contribution for full-time and part-time employees.</p>
