Under the terms of the agreement, the Organization pays Samaritas a management fee equal to 6.14% of rental income which is limited to \$46 per occupied unit per month. Total management fees for the fiscal year ending September 30, 2019 were \$14,030. Samaritas provides certain accounting services to the Organization in accordance with the annual budget. The accounting fees for September 30, 2019 were \$3,120. Samaritas offers employees the opportunity to participate in the ELCA Master Institutional Retirement Plan administered by Portico and their relationship with Fidelity. Employees are eligible to defer a portion of their earnings on a pre-tax basis into the Plan to save for retirement. Samaritas provides a matching contribution for full-time and part-time employees.</p>
