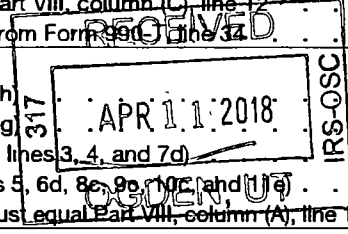

Many of our clients are from low income situations. Payment for their services are provided by fund raising revenue, memorial donations, grants and investment income.**
