INVEST JEFFERSON: JEI THROUGH DIRECT ACTIVITIES AND THOSE OF IT'S DEVELOPMENT SUBSIDIARY - SEEKS TO SUPPORT AND DEVELOP INCLUSIVE NEIGHBORHOODS AND BUSINESS DISTRICTS THAT ALLOW LONGTIME DETROITERS TO BENEFIT FROM THE CITY'S RESURGENCE. IN 2019, JEI CONTINUED WITH ITS RENOVATION OF THE MARLBOROUGH APARTMENT BUILDINGS INTO 23 UNITS OF AFFORDABLE AND MIXED INCOME HOUSING. CONSTRUCTION ALSO CONTINUED ON 6,400 SQUARE FOOT RETAIL BUILDING INTO JEI'S NEW NEIGHBORHOOD RESOURCE HUB AND RESTAURANT SPACE. JEI WORKS WITH WAYNE STATE UNIVERSITY CENTER FOR URBAN STUDIES TO MONITOR CRIME HOTSPOTS AND DEVELOP COMMUNITY DRIVEN RESPONSES TO CRIME IN THE FIVE NEIGHBORHOODS THAT IT SERVES. IN PARTNERSHIP WITH THE DETROIT POLICE DEPARTMENT, JEI RAISES FUNDS TO SUPPORT SECONDARY POLICE PATROLS IN THE NEIGHBORHOODS. SINCE 2013, JEI HAS DRIVEN A 46% REDUCTION IN CRIME RATES INCLUDING AN 8.4% DROP IN 2019.
