WE ACCOMPLISH THIS BY PROVIDING AFFORDABLE HOUSING, ADMINISTERING SUPPORTIVE HOUSING, BEING A LEADING PROVIDER OF HOMELESS PREVENTION AND RAPID RE-HOUSING RESOURCES FOR PEOPLE WHO ARE HOMELESS OR AT RISK OF HOMELESSNESS, PEOPLE WITH DISABILITIES AND OTHER VULNERABLE MEMBERS OF THE SOUTHEASTERN MICHIGAN COMMUNITY, AND OFFERING OTHER HOUSING PROGRAMS INCLUDING HOUSING COUNSELING, FORECLOSURE PREVENTION COUNSELING AND FINANCIAL COUNSELING.THE PRINCIPAL BELIEF SUPPORTING EVERYTHING CHN DOES IS THAT PEOPLE AND COMMUNITIES ARE MORE SUCCESSFUL WHEN EVERYONE - INCLUDING PEOPLE STRUGGLING WITH HOMELESSNESS, THOSE WITH DISABILITIES, AND THOSE WITH LOW INCOMES - ARE PART OF THE FABRIC OF STABLE COMMUNITIES. CRISIS RESPONSEHOUSING RESOURCE CENTERCOMMUNITY HOUSING NETWORK'S HOUSING RESOURCE CENTER (HRC) RECEIVED 15,056 CALLS FROM INDIVIDUALS IN NEED. THIS AMOUNT DOES NOT INCLUDE THE ADDITIONAL 2,328 COVID-19 RELATED CALLS TO CHN SEEKING EMERGENCY HOUSING ASSISTANCE AND EVICTION DIVERSION SUPPORT. THE HRC FUNCTIONS AS A "ONE-STOP SHOP" (FOR THOSE SEEKING RESOURCES RELATED TO HOUSING OR HOMELESSNESS). THIS VITAL PROGRAM ENABLES FAMILIES AND INDIVIDUALS TO ACCESS SERVICES THAT WOULD BEST ASSIST THEM IN GETTING HOUSED OR STAYING HOUSED, WITHOUT HAVING TO NAVIGATE THE "SYSTEM" ON THEIR OWN. THE HRC BECAME A VITAL SERVICE TO THOSE EXPERIENCING HARDSHIPS AS A RESULT OF COVID-19.STREET OUTREACHTHE PROJECTS FOR ASSISTANCE IN TRANSITION FROM HOMELESSNESS (PATH) PROGRAM SERVES THE MOST VULNERABLE AND HARD TO REACH PEOPLE IN OAKLAND AND MACOMB COUNTIES WHO ARE HOMELESS AND LIVING ON THE STREETS. THE PATH OUTREACH TEAM CONNECTED WITH 166 HOMELESS INDIVIDUALS; OF WHICH 71 ENROLLED IN THE PROGRAM AND NOW HAVE INDEPENDENT HOUSING AND ACCESS TO COMMUNITY RESOURCES VIA THE PATH PROGRAM.HOUSING PROGRAMSHOMELESS PREVENTION PROGRAMIN 2020, 93 INDIVIDUALS WERE ASSISTED THROUGH THE HOMELESS PREVENTION PROGRAM; THIS PROGRAM PROVIDES A SHORT-TERM SAFETY NET TO PREVENT PEOPLE FROM LOSING THEIR EXISTING HOUSING AND REMAIN HOUSED.RAPID RE-HOUSING PROGRAMCHN'S RAPID RE-HOUSING PROGRAM HELPS VULNERABLE FAMILIES WITH A RENTAL SUBSIDY FOR UP TO 12-MONTHS. DURING THIS PROGRAM YEAR, 453 INDIVIDUALS WERE HELPED THROUGH THIS PROGRAM; 55% WERE CHILDREN 18 YEARS OR YOUNGER. MULTIFAMILY HOUSING DEVELOPMENTSCOMMUNITY HOUSING NETWORK HAS DEVELOPED 7 HOUSING DEVELOPMENTS IN SOUTHEASTERN MICHIGAN PROVIDING 199 UNITS FOR LOW-INCOME FAMILIES AND PEOPLE WITH DISABILITIES. IN THIS HOUSING, 561 WERE SERVED; 56% WERE CHILDREN AND 58% OF THE HOUSEHOLDS WERE HEADED BY SINGLE MOTHERS.IN LATE-2019, CHN WAS AWARDED TAX CREDITS FOR ERIN PARK IN EASTPOINTE, MICHIGAN AND UNITY PARK V IN PONTIAC. CHN BROKE GROUND ON ERIN PARK IN EASTPOINTE, MICHIGAN IN JUNE 2020. THIS MULTI-FAMILY HOUSING DEVELOPMENT WILL INCLUDE 52 HIGH QUALITY, DUPLEX STYLE, ONE-, TWO- AND THREE-BEDROOM HOMES.HOMEBUYER & FINANCIAL EDUCATIONCHN IS COMMITTED TO HELPING FAMILIES ACHIEVE FINANCIAL GOALS AND DREAMS OF HOMEOWNERSHIP. CHN'S HOMEBUYER AND FINANCIAL EDUCATION CLASSES ARE DESIGNED FOR INDIVIDUALS AND FAMILIES TO BE SUCCESSFUL WITH TAKING THE NEXT STEP TOWARD HOUSING STABILITY AND ASSET BUILDING. IN 2020, 1,038 HOUSEHOLDS WERE SERVED THROUGH HOMEBUYER AND FINANCIAL EDUCATION PROGRAMS.VOLUNTEER ENGAGEMENTCOMMUNITY HOUSING NETWORK OFFERS A VARIETY OF OPPORTUNITIES FOR COMMUNITY VOLUNTEERS AND STUDENT INTERNS. DURING 2020, 114 VOLUNTEERS AND INTERNS PROVIDED 5,230 HOURS OF SERVICE TO THE ORGANIZATION.
