EDUCATION ACCESS HEALTH, IN COLLABORATION WITH MUSKEGON COMMUNITY COLLEGE AND THE MICHIGAN COMMUNITY HEALTH WORKER ALLIANCE, LAUNCHED THE COMMUNITY HEALTH WORKER TRAINING PROGRAM. A MEMBER OF THE ORGANIZATION PROVIDES EDUCATION AND TRAINING TO THE STUDENTS PARTICIPATING IN THE PROGRAM. SIMS ACCESS HEALTH PROVIDES SERVICES IN CONTRACT AND COORDINATION TO DEVELOP CARE PLANS AND PROVIDE ANALYSIS OF EMERGENCY ROOM UTILIZATION DATA FOR THE MUSKEGON CARE POPULATION.
