What is the organization's primary exempt purpose? The mission of Love In the Name of Christ of Yakima is to empower our neighbors to "get unstuck" and equip them for freedom. We network churches, volunteers, social services, and organizations to efficiently and effectively connect to those in need without our community and to equip them to live in spiritual, personal, and financial freedom. Our goal is to transform individuals, families, and communities in the name of Christ.

28 Connection Center Ministry Trained volunteers receive requests for help. We assess the legitimacy and extent of the need, then refer the people in need to the local church ministry or agency that can best meet that need. In 2016 we served 373 families; received 597 calls for assistance, provided 302 referrals to our partner churches and 145 referrals to community agencies, met 609 specific needs, including clothing, hygiene products, cleaning supplies, household linens, kitchen supplies, furniture, baby supplies, and school supplies. Our team of office/connection center volunteers included 547 individuals providing 3,032 hours of service, and 202 partner churches volunteers providing 515 service hours. The recorded value of items donated to us to be distributed to those in need in the community included \$72,137 in in-kind donations of food, clothing, hygiene items, household goods, cleaning supplies, baby supplies, school supplies, office supplies, oil changes, haircuts, car repair, counseling and classes taught.

29 TEAM (Training, Equipping And Mentoring) Ministry. TEAM is a comprehensive transformational program begun in 2012 that is designed to help those struggling to make ends meet. The TEAM program, which runs weekly and takes at least one year to complete, includes classes on budgeting and instruction on helpful life skills; ongoing coaching from a budget mentor, help with material needs for participants, a Christian program for children through age 12. These classes are carefully designed to equip people in poverty and those struggling to stay out of poverty with vital skills they need to lead new productive, and self-sufficient lives. Orientations are held 5 times throughout each year, and clients can begin the program after attending any of the orientations. There are 48 families that attended an orientation in 2016, including 3 families that graduated from the program during the year. These participants are able to earn vouchers for their participation which they can redeem for weekly groceries, gas cards, and other needs and services. Using these earned vouchers for weekly necessities frees up participant's income to pay back debt. During 2015, TEAM participants redeemed 260 vouchers for pantry items which supplied them with weekly groceries, hygiene items, and cleaning products, 74 vouchers for 37 \$25 gas cards; 20 vouchers for other goods and services. Total debt paid off since the program started in 2012 is \$143,000.

30 Volunteer Training Equipping seminars are designed to equip people for effective ministry to the hurting, are available to churches and small groups. These trainings include the following subjects: impact of childhood trauma, domestic violence, understanding addiction, relationship addiction; resiliency, ethics, boundaries, teaching a growth mindset, the genesis personal change tools, the defining difference - a look at poverty in America, root causes and effective poverty alleviation. The life skills classes at TEAM are also available to anyone staff or volunteering with Love INC. These weekly one-hour classes cover many of the topics in the equipping seminars, but also include identity theft, anger management, stress management, cooking on a budget, healthy living, and conflict resolution. In 2016 a total of 142 individuals participated in 219 hours of training.
