Our mission is to raise money for green projects and to educate the public about the most pressing environmental issues facing the planet today. Our overall goal is to help conserve, protect, and improve the environment through funding green projects and through education, which includes STEAM, nutrition, and conservation education in K-12 schools.

Green Our Planet (GOP) helped fund and install 30 outdoor garden classrooms in the Clark County School District in 2016. GOP now works with 100 schools with more than 60,000 students in attendance. Each garden classroom consists of 6 raised garden beds, 8'x4' in size, consisting of 14,112 square feet of garden able to produce 500 pounds of vegetables twice a year. The 100 gardens are able to produce a total of 100,000 pounds of produce a year. Many studies have shown that students taught in outdoor teaching gardens score considerably higher on tests for math, science, and other subjects. Green Our Planet was able to fund 12 Clark County School District Teachers and 3 farmers from Garden Farms to create a STEAM curriculum to Nevada State Standards and Next Generation Science Standards which is now being used by 85 elementary schools. GOP also partnered 60 schools with a chef who went into the schools and prepared and cooked food from the gardens with the students. In addition, Green Our Planet helped 80 schools implement and run farmers markets at their respective schools in 2016.

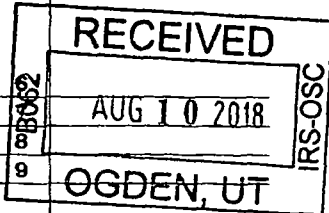
