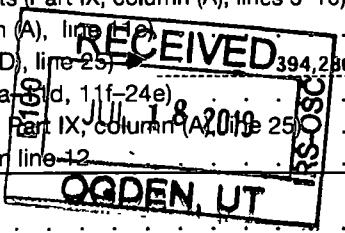

Residential Summer Camp: 459 children ages 8-13 attended one of six 5-day sessions. 72% of those children came from low income families and paid \$40 or less to attend. Children took part in enrichment activities including educational workshops, swimming, biking, hiking, archery, reading, arts and crafts, and much more. Goals of the camp program are both short- and long-term. Youth served will initially have a safe and constructive place to spend a week; they will learn life skills such as positive decision-making and social behavior; and they will have an awareness of their own abilities and assets. In the longer term, participants will have increased respect for others, and will demonstrate improvements in school such as better grades and attendance. Off season use of the camp facility included 88 individual, church, school, and other groups.

4b (Code:) (Expenses \$ 52,583 including grants of \$ 0) (Revenue \$ 4,216)

Camp Blodgett STEM Academy: 39 children entering 5th through 8th grades attended this 4-week summer program. Participants had three hours of academics (focusing on science, technology, engineering, and math) taught by certified and motivated teachers using experiential, hands-on involvement and innovative methods. For the remainder of the day, participants joined other campers in traditional camp activities such as swimming, archery, and workshops. The goal of STEM Academy is to provide vulnerable children with the opportunity to reverse the effects of summer learning loss and realize academic achievement. Year-round STEM programming includes STEM Squad Saturdays that meet twice per month in one of three locations and features STEM activities that are both skill-building and fun.

Camp Blodgett Club After-School Program: Approximately 30 children ages 8-13 attended twice per week after school in one of two locations. The Club was established to stay in touch with campers and potential campers during the school year to continue the positive message of the summer program, that is, encouraging educational success and instilling self-esteem and confidence. Activities of Camp Blodgett Club included homework assistance, arts and crafts, community service projects, physical activities, and nutritious snacks. This program is being phased out in order to allocate resources to year-round STEM programming expansion.
