FORMAL REVIEW MATERIALS ARE COMPILED AND REVIEWED BY THE COMMITTEE, AND RECOMMENDATIONS FOR ADJUSTMENTS TO COMPENSATION ARE MADE AT THIS TIME. THE ACTION IS DOCUMENTED BY THE COMMITTEE FOR THE ORGANIZATION'S RECORDS, AND THE EVALUATION IS PERFORMED IN PERSON BY THE BOARD PRESIDENT WITH THE CEO. |
