LIVE- OUR LONG- AND SHORT-TERM HOME OWNERSHIP PROGRAMS HELP LARGER, LOW-INCOME FAMILIES WORK TOWARD FIRST-TIME HOMEOWNERSHIP. THE LONG-TERM PROGRAM IS UNIQUE IN COMBINING FEDERAL SECTION 42 TAX CREDITS WITH COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUNDS TO HELP FAMILIES PURCHASE SINGLE FAMILY HOMES THROUGH A LEASE-TO-PURCHASE MODEL. THE PROGRAM OFFERS QUALITY, AFFORDABLE HOUSING IN SAFE AND STABLE NEIGHBORHOODS FOR FAMILIES EARNING LESS THAN 60% OF THE AREA MEDIAN INCOME LEVEL. THIS PROGRAM IS OPERATED THROUGH A PARTNERSHIP WITH MADISON COMMUNITY REINVESTMENT ASSOCIATES (AN LLC THAT INCLUDED THE WISCONSIN AFFORDABLE HOUSING CORPORATION AND U S BANCORP). THE SHORT-TERM PROGRAM UTILIZES ONLY CDBG FUNDS AND MORTGAGE FINANCING. IN 2015, 28 FAMILIES WERE PARTICIPATING IN THE LONG-TERM PROGRAM AND 2 FAMILIES IN THE SHORT-TERM PROGRAM. ALSO IN 2015, 2 FAMILIES PURCHASED THEIR HOME THROUGH THE PROGRAM.
