WE ACHIEVE OUR MISSION THROUGH THREE METHODS THAT ARE INTEGRATED INTO ALL PROGRAMS: EDUCATION, RELATIONSHIP BUILDING, AND EXPOSURE. JOURNEY HOUSE IS COMMITTED TO TWO AGENCY-WIDE PROGRAMS THAT STRENGTHEN PROGRAM DELIVERY AND OUTCOMES: YOUTH EMPOWERMENT SEMINAR (YES!) AND COMMUNITY BUILDING MILWAUKEE (CBM). THE YES!
