The Corporation was formed to strengthen and serve Community Action in Wisconsin. In this role it shall Act as an advocate for the low-income at all levels of government, Encourage, promote and stimulate the development of resources which demonstrate progress toward the elimination of poverty, Promote mutual understanding among member agencies and state and local organizations to further the goals of Community Action, Recommend appropriate action to member agencies on pending legislation, Appoint, elect or nominate representatives of member agencies to various state and regional boards, commissions, councils and committees, Promote professional growth and competence of members through training and support in the solution of administrative problems affecting Community Action as a whole, Accept and administer grants and contracts for the purpose of conducting programs, Secure funds and hire staff to manage and administer corporation affairs and specific projects for planned operations

**4a** (Code ) (Expenses \$ 443,552 including grants of \$ 443,552 ) (Revenue \$ 2,877 )  
 Asset development programs (1) provide assistance to low-income entrepreneurs through the Job & Business Development Program (JBD) to start new businesses or expand existing businesses to create jobs, and (2) provide training to low-wage workers through the Skills Enhancement Program (SEP) so they can obtain better paying jobs with access to employer health insurance. Asset Development Programs are primarily supported through federal and state government grants. 90% of the funds received to support this program are sub-contracted out to 9 501(C)(3) organizations to operate the program. Under the Job and Business Development program (JBD) the corporation has assisted 60 low-income entrepreneurs with starting their own business, created 66 new full-time jobs, preserved 27 full-time jobs, and leveraged \$426,000 in loans and grants to low-income entrepreneurs in Wisconsin. The Skills Enhancement Program (SEP) has provided services to 338 low-wage workers through 15 member agencies. 57 SEP graduates have reported obtaining new jobs as well as an increase of \$10,631 per grad in annual wages and 68% have access to employer health insurance. Each graduate is projected to earn \$376,000 more in income over their working lifetimes.

**4b** (Code ) (Expenses \$ 417,032 including grants of \$ 40,164 ) (Revenue \$ 81,079 )  
 Training and development. These programs are designed to increase the capacity of the 19 Community Service Block Grant-funded entities in Wisconsin to produce and achieve intended results. The training programs strengthen the organizational, financial, and program capacity of participants and enhances and sustains their ability to plan, deliver, manage and evaluate programs to produce intended results for low-income people in Wisconsin. In 2015, Wisconsin Community Action Program Association, Incorporated (WISCAP) organized and administered 2 large conferences, the A Home for Everyone Housing Conference (AHFE) and the Poverty Matters! Conference. Attendance for AHFE included 121 registered participants, attendance for Poverty Matters! included 148 registered participants. WISCAP also sponsors quarterly meetings of its membership and the four quarterly meetings in 2015 had registered attendance of 350 participants.

 Rural community assistance program (RCAP) provides assistance to eligible individuals in rural communities on water and wastewater issues. This activity is primarily supported through federal and state government grants. In 2015, RCAP assisted 32 different small, rural communities with 40 projects. RCAP also includes the Tribal Circuit Rider Program which provides services to all 11 Wisconsin tribal utilities.
