The Sisters Program The Sisters Program helps over 400 women per year in street prostitution or sex trafficking find hope, skills and support to live healthier, safer lives. The program is an innovative partnership with the Milwaukee Police Department, community groups and neighborhoods where police divert women to the Sisters Program in lieu of arrest. It provides a harm-reduction approach that includes street-outreach and two drop in centers where women can begin their healing journey. At the drop in centers, women can safely rest and receive crisis management, counseling, advocacy and assistance connecting to housing and other critical resources. Sisters participants engage in on-going peer support, and give input on program design.

Form 990, Part III, Line 4b:

The Womens Harm Reduction Program serves women who are deferred by the courts or referred by probation as an alternative to incarceration. Approximately 200 women participate in services for an average of 6 months including creating individualized plans that identify personal goals and resource/skills needs, substance abuse and mental health treatment based on each persons assessment, and psychosocial education including cognitive behavioral therapy, trauma coping skills groups, anger and stress management classes, parenting classes, adult education and employment assistance. The Womens Reentry Program is an extension of the program, a partnership with the Milwaukee County House of Correction, to provide services at their site for women who are incarcerated and ready to re-enter the community. The goal is to reduce the risk of recidivism by providing women with individualized reentry planning, case management, life skills training and education that focuses on reducing barriers to employment and goals for reentry into the community.

Form 990, Part III, Line 4c:

The Community Justice Program and our direct services are mutually reinforcing efforts. Our agency advocates for best practice and cost-effective policies for women in the criminal justice system. Our current advocacy focus is to create a citywide prostitution diversion policy. This will culminate in women being diverted to the expanded Sisters Program on the north and south sides. This represents a shift from criminalizing women in the sex trade. Instead, it provides a public health approach that helps them address issues including violence, trauma, poverty and addiction while treating them with dignity and respect.
