St Joseph's Medical Clinic, Inc provides health care services to uninsured and low-income individuals and families who reside, work, or attend higher education in the Waukesha County community Individuals are eligible if their household income is 250% or less of federal poverty rates and have no health insurance In the year 2015 The professional staff and volunteers provided 460 clinic exams, 774 medications were supported, and 806 labs or diagnostics were completed There were 55 referrals to address health needs to network providers In addition, medical case management was provided to 12 individuals with complex health conditions In 2015 there were over 1,014 information and or referral calls from individuals who sought a variety of needed services These calls included referrals for dental needs, food, shelter, social services, mental health, medications and health In 2015, 36 classes were provided to groups in collaboration with partners such as Komen Breast Health and Dental and Diabetic educators
