Homeless Veteran Re-Integration Program -The Homeless Veteran Re-Integration Program (HVRP) is a Department of Labor Grant Program managed by a cooperative effort between the Community Action Coalition (CAC) and the Employment and Training Association to serve Dane County's Homeless Veterans. The primary purpose of HVRP is to help homeless veterans secure and retain employment so they may re-enter mainstream society as productive citizens. To accomplish this goal, the program operates weekly program orientations, job clubs, soft-skills training workshops and provides access to occupational skills training opportunities focused on the needs of industry.
