THE ORGANIZATION HAS BEEN FURTHERING THE SECOND AND FIFTH MISSIONS BY ASSISTING HOUSEHOLDS WITH WATER NEEDS AND BY ALERTING AND COORDINATING WITH OTHERS TO ADDRESS FUTURE WATER NEEDS.
