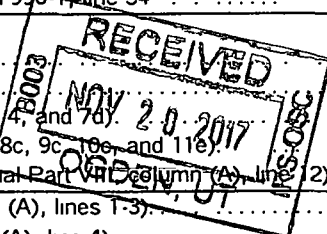

**Explanation of Amended 2015 Form 990**

Return was amended to correct for fixed assets which had originally been recorded as being disposed of as part of an equipment replacement that were in fact still owned and being used by the YMCA. The effect of the amendment was to adjust the basis of asset sold other than inventory from \$56,990 to \$38,112 and the equipment amount listed on Schedule D, Part VI, line 1d from \$148,998 to \$163,943. The depreciation expense on Part IX, line 22 was adjust from \$131,768 to \$135,701 along with the corresponding cost and accumulated depreciation amounts in Part X, lines 10a and 10b. These changes are reflected in Parts X and XI of the 990 and Schedule D, Part VI, line 1c, Part XI, line 4b and Part XII, lines 1 and 2d.

In addition, the Unrestricted net assets were adjusted from 1,352,753 to 1,361,946 and the Temporarily restricted net assets were adjusted from 32,078 to 37,830 as reflected in Part X lines 27 and 28.
