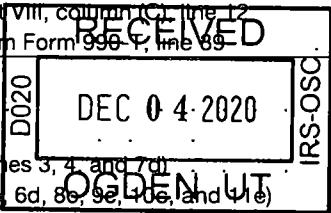

LSS Housing is managed by Lutheran Social Services of Wisconsin and Upper Michigan whose mission is "Act Compassionately. Serve Humbly. Lead Courageously." Some of the property amenities include an on-site manager, community room, on-site laundry facilities, pets allowed, cable hookup and secure buildings.
