This was almost a year long process of working with the company's site selector, City of Shawano officials and various utilities and contractors. Worked with City of Shawano officials and Dunham's Sports to locate a new Dunham's store in the KMart Plaza. Solicited suggestions from area employers about what they view is important for workforce development and discussed with Vision 2017 Oversight Committee on how to attract both working partners to a community. How might businesses in an area partner to provide options for each of the working partners and is this of value?
