The Company provides care to patients who meet certain criteria under its community care policy without charge from 7/1/16 to 6/30/17. The estimated cost of providing care to patients under ACI's community care policy aggregated approximately \$712,000 in fiscal year 2017. The cost was calculated by multiplying the ratio of cost to gross charges for ACI times the gross uncompensated charges associated with providing the community care. The Clinic employed 97 FTE providers who had 270,072 visits from patients. The Clinic also provides services to beneficiaries of the Medicare and Medicaid programs which often reimburse the Clinic based on predetermined fee schedules which are often below the cost of providing care to these individuals. These programs represent a large portion of the elderly, low income, and disabled members of the community who need access to high quality care. During fiscal year 2017, Medicare and Medicaid programs made up approximately 43.5% of gross patient revenue.
