South Willow is managed by Lutheran Social Services of Wisconsin and Upper Michigan whose mission is "Act Compassionately. Serve Humbly. Lead Courageously." Some of the property's amenities include an on-site manager, community room, on-site laundry facilities, well maintained landscaping with outdoor seating areas, pets allowed, secure building, cable hookup and furnished refrigerators and ranges.
