Since 2004, MCSC has completed the production of nearly 12,000 rain barrels that have been distributed to local homeowners to reduce the impact of runoff into Milwaukee waterways. MCSC has also been instrumental in the removal of the algae building up along Milwaukee's beaches, the retrofit and energy efficiency improvement of Milwaukee older housing stock, the remediation of brownfield properties contaminated with hazardous waste and an installation of specialist to train Milwaukee's young adults to become solar installation technicians and residential energy auditors.**
