Fox Valley Literacy's mission is to share the power of learning to transform lives and enrich the community. We provide adult basic education and english language education through group classes and one-on-one tutoring by trained volunteers. We provide free assistance to students to help them achieve goals; to get a GED, or a driver's license, to pass the citizenship test, or to be able to help with their child's homework, or expand their own career or employment opportunities, etc.

Our staff trains, assists and provides continuing education opportunities for volunteer tutors. These volunteers provide one-on-one tutoring to adult students seeking to improve literacy skills. Our staff also trains volunteers to lead some group learning or conversation sessions and the staff leads some group sessions as well. Our office space includes classrooms that are used for the student-tutor learning sessions and a larger, group class learning area. In addition we provide a computer area where students can work on on-line learning in our offices.

During 2019 over 60% of students studying for citizenship became citizens; 87.5% of students who took a standardized 100 hour literacy test showed improvement; more than 25% of our students met a long-term, multi-year goal.
