"HOMEOWNER EDUCATION: STAFF AND VOLUNTEERS TAUGHT 29 EDUCATIONAL/ TRAINING COURSES FOR APPLICANTS, CURRENT HOMEOWNERS, AND PAST HOMEOWNERS TO HELP PREPARE THEM FOR THE RESPONSIBILITY OF HOME-OWNERSHIP. COURSES RANGE FROM HOME MAINTENANCE TO LANDSCAPING TO BUDGET COUNSELING. BY OFFERING THESE COURSES, HABITAT HELPS FAMILIES TO STAY IN THEIR HOMES AND MAINTAIN THE QUALITY OF THEIR NEIGHBORHOOD. THE RENTALS PROVIDE A BRIDGE TO HOME OWNERSHIP AND PROVIDES AN AVENUE FOR FAMILIES THAT ARE EITHER IN AN UNSAFE OR UNAFFORDABLE HOUSING SITUATION. THE SUCCESSFUL TWELVE-YEAR-OLD PROGRAM CURRENTLY SERVES OVER 156 PEOPLE PER YEAR AND HAS BEEN A MAJOR FACTOR IN REDUCING HABITAT HOMEOWNERS DELINQUENCY RATES TO WELL BELOW THE NATIONAL AVERAGE. "
