PARENT TRAINING AND INFORMATION CENTER (U.S. Dept of Ed./Office of Special Ed. Programs Grant)

Purpose provide training, information & support to families of children with disabilities & others in WI. Trained 5,289 persons. Reached 2,770 parents, 401 professionals & 274 youth through calls, emails, letters and in-person meetings. Conducted 80 exhibits where 16,764 were reached with information. Social media efforts reached 247,698. Project staff attended 179 stakeholder/policy/task force meetings to work on systems change initiatives. Supported families at 45 IEP meetings, & 21 mediations and facilitated IEPs. Outcomes 87% of parents reported the information they received from WI FACETS met their needs, 83% report feeling confident to work with their child's school after receiving support from WI FACETS, 87% of parents served would recommend WI FACETS to other families.

REGIONAL PARENT TECHNICAL ASSISTANCE CENTER (U.S. Dept of Ed./Office of Special Ed Programs Cooperative Agreement)

Purpose provision of technical assistance to OSEP-funded parent centers. # served: 11 federally-funded parent centers in 8 states (IA, IL, IN, MI, MN, MO, OH, WI). The project website (www.region4ta.us) contains archived webinars & many online resources to assist parent centers to implement their grants. Over 230 direct requests for TA were responded to, a weekly Region 4 newsbrief was published with resources related to non-profit management, technology, outreach, parent services, multicultural issues, education practices, etc. 26 workshops were offered to centers. Staff participated in 157 collaboration activities. A University-sponsored nonprofit management certificate program with 12 hours of programming was provided. A cohort group of Spanish-speaking parent centers staff was convened to address issues related to serving Spanish-speaking families more effectively. Outcomes: 92% of training participants reported webinars were of high quality. 90% of individuals from parent centers who received technical assistance said it was useful and 86% reported it was relevant to the work they are doing at their parent center.

STATE PERSONNEL DEVELOPMENT GRANT (WI DPI Grant) - SPDG

Purpose: To increase the participation of family and community members in the systems change process of selected schools through the use of professional development. 18 Serving on Groups that Make Decisions trainings were conducted, reaching 168 parents and professionals. The WI Family Engagement Newsletter was published 12 times that reached 30,621. Topics included: transition, speech and language, OHI, deaf & hard of hearing, ADD/ADHD, learning disabilities, multicultural learners, autism, and mental health. Self-paced online learning modules can be found on the website: www.servingongroups.org. Outcomes: 100% of participants found the training to be of a high quality; 100% found the training useful, and 100% would share the training with others.

Outcomes 95% of youth rated leadership training useful, 84% of parents believed training improved child's IEP participation.

EARLY LEARNING & LITERACY INITIATIVE (WI Dept of Public Instruction Discretionary Grant)

Purpose to increase literacy knowledge and engagement amongst MPS families of children with disabilities. Provided 70 workshops to 900 parents and others on supporting literacy at home, early literacy & technology, preschool options. 16 exhibits were held where 3,200 units of informational resources were distributed. 6 families completed an intensive literacy training course. Outcomes. 100% of literacy course participants reported increased confidence to support their child's literacy at home. 80% of course participants reported increased understanding of how the school evaluates their child's reading.

WISCONSIN EARLY LEARNING & LITERACY INITIATIVE (WI Dept. of Public Instruction Discretionary Grant)

Purpose. to increase literacy knowledge and engagement amongst families of young kids with disabilities statewide. Provided 48 trainings to 386 parents and other supporting young learners. Trainings covered topics such as summer reading, library access, mindfulness, components of literacy and preschool options. Direct information and referral support was provided to nearly 480. Outcomes. 87% of training participants reported an increased understanding of literacy and related topics following the training.
