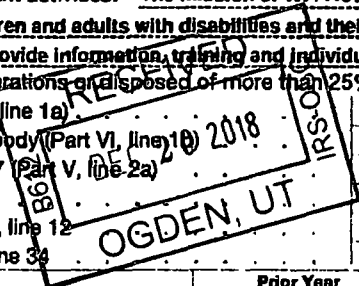

**PARENT TRAINING AND INFORMATION CENTER (U.S. Dept of Ed/Office of Special Ed. Programs Grant)**

Purpose: provide training, information & support to families of children with disabilities & others in WI. Trained 5,052 persons Reached 3,030 parents, 441 professionals & 223 youth through calls, emails, letters and in-person meetings. Conducted 63 exhibits where 14,615 pieces of information were disseminated. Social media efforts reached 104,968. Project staff attended 154 stakeholder/policy/taskforce meetings to work on systems change initiatives. Supported families at 45 IEP meetings and 6 mediations Outcomes: 90% of parents reported the information they received from WI FACETS met their needs; 83% reported feeling confident to work with their child's school after receiving support from WI FACETS; 100 % of parents surveyed would recommend WI FACETS to other families.

**REGIONAL PARENT TECHNICAL ASSISTANCE CENTER (U.S. Dept of Ed/Office of Special Ed. Programs Cooperative Agreement)**

Purpose: provision of technical assistance to OSEP-funded parent centers. # served: 11 federally-funded parent centers in 8 states (IA, IL, IN, MI, MN, MO, OH, WI). The project website (www.region4ta.us) contains archived webinars & many online resources to assist parent centers to implement their grants. Over 137 direct requests for TA were responded to; the Region 4 News Brief was published on a weekly basis with resources related to nonprofit management, technology, outreach, parent services, multicultural issues, education practices, etc. 39 workshops were offered to centers. Staff participated in 260 collaboration activities. A University sponsored non profit management certificate program with 12 hours of programming was provided. A cohort group of Spanish-speaking parent centers staff was convened to address issues related to serving Spanish-speaking families more effectively. Outcomes: 86% of training participants reported webinars were high quality. 87% of individuals from parent centers who received technical assistance said it was useful and 88% reported it was relevant to the work they are doing at their parent center.

**FAMILY ENGAGEMENT & LITERACY (WI Dept. of Public Instruction Discretionary Grant)**

Purpose: To increase the participation of family and community members in the systems change process and to increase literacy knowledge and engagement amongst families of students with disabilities statewide. Provided training to 575 parents and others, on supporting young learners, literacy and technology. Trainings covered topics such as summer reading, library access, mindfulness, components of literacy and preschool options, Serving on Groups that make decisions, special education, and trauma informed. Direct information and referral support was provided to nearly 292. Outcomes: 100% of training participants reported an increase in understanding of literacy and related topics following the training. 100% of literacy course participants reported increased confidence to support their child's literacy at home. 93% of course participants reported increased understanding of how the school evaluates their child's reading. The monthly WI Family Engagement Newsletter reached 30,084. The Literacy Project training of trainers trained 40 participants, 85% of them responded that they are confident to implement the training. The annual "Endless Possibilities" conference was attended by 234.
