PARENT TRAINING AND INFORMATION CENTER (U.S. Dept of Ed/Office of Special Ed. Programs Grant)
 Purpose: Provide training, information and support to families of children with disabilities and others in WI. Trained 4,330 persons. Reached 2,647 parents, 537 professionals & 250 youth through calls, emails, letters and in-person meetings. Conducted 50 exhibits where 26,320 pieces of information was disseminated. Social media efforts reached 140,794. Project staff attended 133 stakeholder/policy/taskforce meetings to work on systems change initiatives. Supported families at 53 IEP meetings, and 18 mediations. Outcomes: 92% reported feeling prepared to use the information they received; 84% of parents surveyed would recommend WI FACETS to other families. 60,101 website visits (www.wifacets.org)

REGIONAL PARENT TECHNICAL ASSISTANCE CENTER (U.S. Dept of Ed/Office of Special Ed. Programs Cooperative Agreement)
 Purpose: Provision of technical assistance to OSEP-funded parent centers. #served: 19 federally funded parent centers in 16 states (IA, IL, IN, KS, KY, MI, MN, MO, MT, NE, ND, OH, SD, WV, WI, WY). The project website (www.regioncptac.org) contains archived webinars and many on-line resources to assist parent centers to implement their grants. Over 138 direct requests for TA were responded to. The Region C Bite Sized Professional Development Messages were published on a weekly basis with resources related to nonprofit management, technology, outreach, parent services, multicultural issues, education practices, etc. 5 webinars were offered to centers. A university sponsored nonprofit management certificate program with 10 hours of programming was provided. Outcomes: 93% reported the information was useful and 96% reported that the content was relevant. 93% of individuals from parent centers who received technical assistance said it was useful.

FAMILY ENGAGEMENT & LITERACY (WI Dept of Public Instruction Discretionary Grant)
 Purpose: To increase the knowledge and engagement of families to take a more active role in the education of their children with disabilities, in relation to special education, evidence-based education practices, RtI, PBIS, literacy awareness and improving literacy outcomes for students with disabilities. Provided trainings to 166 parents and others on supporting young learners, literacy and technology. Trainings covered topics such as summer reading, library access, components of literacy and technology, response to intervention and parents serving on groups that make decisions among others. Outcomes: 100% of training participants reported an increase in understanding of literacy and related topics; 100% reported increased confidence to support their child's literacy at home; 96% reported an increased understanding of how the school evaluates their child's reading. The monthly WI Family Engagement Newisetter reached 31,884. The Literacy Project training of trainers in Spanish reached 6 participants. The annual "Endless Possibilities" conference was attended by 200.
