PARENT TRAINING AND INFORMATION CENTER (U.S. Dept of Ed/Office of Special Ed. Programs Grant)

Purpose: Provide training, information & support to families of children with disabilities & others in WI. Trained 3,730 persons. Reached 2,638 parents, 472 professionals & 109 youth through calls, emails, letters and in-person meetings. Conducted 7 exhibits where 20,029 pieces of information were disseminated. Social media efforts reached 331,647. Project staff attended 78 stakeholder/policy/taskforce meetings to work on systems change initiatives. Supported families at 55 IEP meetings and 15 mediations. Outcomes: 91% reported the information that they received from WI FACETS was useful; 82% reported feeling prepared to use the information they received; 100% of the parents surveyed would recommend WI FACETS to other families. 59,613 website visits (www.wifacets.org)

REGIONAL PARENT TECHNICAL CENTER (U.S. Dept of Ed/Office of Special Ed. Programs Cooperative Agreement)

Purpose: provision of technical assistance to OSEP-funded parent centers. # served: 19 federally funded parent centers in 16 states (IA, IL, IN, KS, KY, MI, MN, MO, MT, NE, ND, OH, DS, WV, WI, WY). The project website (www.regioncptac.org) contains archived webinars & many online resources to assist parent centers to implement their grants. Over 264 direct requests for TA were responded to; the Region C Bite Sized Professional Development Messages were published on a weekly basis with resources related to nonprofit management, technology, outreach, parent services, multicultural issues, education practices, etc. 6 webinars were offered to centers. A university sponsored nonprofit management certificate program with 10 hours of programming was provided. Outcomes: 93% of participants reported webinars were high quality, 93% reported the information was useful and 93% reported that the content was relevant. 92% of individuals from parent centers who received technical assistance said it was useful.

FAMILY ENGAGEMENT & LITERACY (WI Department of Public Instruction Discretionary Grant)

Purpose: To increase the knowledge and engagement of families to take a more active role in the education of their children with disabilities, in relation to special education, evidence-based education practices, RtI, PBIS, literacy awareness and improving literacy outcomes for students with disabilities. Trainings covered topics such as summer reading, components of literacy, serving on groups that make decisions, response to intervention, positive behavior interventions and supports, cultural responsiveness and special education, including specific trainings on supporting families through the special education process for language interpreters and translators. Outcomes: 100% of survey respondents reported the content of the training was relevant to them/their needs; 100% reported an increased knowledge related to understanding or supporting literacy efforts after the training; 90% reported increasing their interpretation skills related to special education. The monthly WI FACETS Engagement Newsletter reached a minimum of 35,152. The annual "Endless Possibilities" conference was attended by 200
