Willow Wood is managed by Lutheran Social Services of Wisconsin and Upper Michigan whose mission is "Act Compassionately, Serve Humbly, Lead Courageously". Some of the property's amenities include an on-site manager, community room, on-site laundry facilities, well maintained landscape with outdoor seating areas, pets allowed, secure building, cable hookup and furnished refrigerators and ranges.
